The 24 fl. oz./A rate of Fusilade II also provides excellent control of **goosegrass** and **dallisgrass**.

Treatments of Recognition at 1.95 oz./A, Recognition + Fusilade II at 1.95 oz./A and 12 fl. oz./A and Dismiss® NXT herbicide at 10.2 oz./A were applied in South Carolina on July 1 and July 29, 2021, in Tennessee on July 28 and Aug. 23, 2021, in Florida on May 17 and June 16, 2021, in Virginia on July 21 and Aug. 18, 2021 and in Indiana on July 28 and Aug. 23, 2021.

To control bermudagrass out of established zoysiagrass:

- Apply Recognition at 1.29-1.95 oz./A with Fusilade II at 24 fl. oz./A. Fusilade II is foliarly absorbed so it's best to apply once the bermudagrass begins to regrow
- Include a non-ionic surfactant at 0.25% v/v or 0.32 fl. oz./gal. of spray solution
- Use spray volumes from 20-80 gal. of water/A
- Use flat-fan nozzles that produce medium-to-coarse droplets to ensure uniform foliar coverage
- Provide adequate fertility and irrigation to encourage zoysiagrass growth and spread
 - Avoid overfertilization, only use 2-3 lb. N/1,000 ft.² per year
- Additional applications may be needed to maintain bermudagrass control until the zoysiagrass can spread into the voids left behind
 - Application intervals vary by time of year and growing conditions, but with 24 fl. oz./A of Fusilade II, a five- to sixweek application interval is typical
